LBCCG has been working with Nathan Colley since 2015, the most recent project was completed in 2021/22. The February 2022 'rain bomb' resulted in very high stream flows damaging the fencing and newly planted riparian tubestock. Also damaged beyond repair was the low-level concrete stream crossing constructed in 2016 by a one metre erosion head undermining the structure, with the crossing breaking in two despite 100 mm thick concrete and steel reinforcement. The proposed project will repair 100 metres of damaged fencing to exclude livestock from the riparian zone. This project is the final stage of two-stage project plan. Stage 1, delivered in 2022/23, focused on the installation of an off-streat watering system. Stage 2 will involve the installation of 2,200 m of riparian fencing along Obi O Creek, to exclude and manage livestock grazing in the riparian zones on the Engle Property.
